

## **TPG Announces Full Exercise and Closing of the Over-Allotment Option in Connection with its Initial Public Offering**

**San Francisco & Fort Worth, Texas – February 9, 2022** – TPG (Nasdaq:TPG), a leading global alternative asset management firm, today announced that, in connection with its previously announced initial public offering of 33,900,000 shares of its Class A common stock (consisting of 28,310,194 shares issued and sold by TPG and 5,589,806 shares sold by an existing strategic investor), the underwriters have exercised their option in full to purchase an additional 3,390,000 shares of Class A common stock (consisting of 1,775,410 shares issued and sold by TPG and 1,614,590 shares sold by the existing strategic investor) at a public offering price of \$29.50 per share. The issuance and sale of these additional shares closed today.

J.P. Morgan, Goldman Sachs & Co. LLC, Morgan Stanley and TPG Capital BD, LLC acted as joint lead book-running managers for the offering. BofA Securities, Citigroup, Deutsche Bank Securities, Evercore ISI, UBS Investment Bank, Wells Fargo Securities, BMO Capital Markets and Barclays acted as joint book-running managers, and Mizuho Securities, Keefe Bruyette & Woods, a Stifel Company, MUFG, SMBC Nikko, AmeriVet Securities, Blaylock Van, LLC, C.L. King & Associates, Drexel Hamilton, R. Seelaus & Co., LLC, Ramirez & Co., Inc., and Siebert Williams Shank acted as co-managers for the offering.

A registration statement relating to the sale of these securities was declared effective by the Securities and Exchange Commission on January 12, 2022.
